NYC Emergency Management

- City of New York
 - 8.8 million people
 - \$1.26 trillion GDP
 - 5 counties/boroughs
 - 469 total square miles
 - 520 miles of coastline
- NYC Government
 - \$115.9B Operating Budget
 - 50+ Agencies (additional 20+ non-mayoral entities)
- NYCEM
 - Mission: To help New Yorkers before, during, and after emergencies
 - 300+ Headcount
 - \$80M Operating Budget

Why Grants Matter

- Emergency management is underfunded.
 - Increasing frequency in severe weather events.
 - Expanding definition of what is an "emergency".
- Grants provide critical resources during emergencies.
- Preparedness and mitigation are cheaper than recovery.
- Grants management builds great management.
- Success in managing grants creates more opportunities for funding.

What is Grants Management

- Grant management is the comprehensive process of overseeing all activities related to a grants, from its initial application to its final closure.
- Grants management can seem intimidating, however in many cases it's following best practices to prevent waste, fraud, and abuse.
- Grants Management is just great project management.

 - Document Management
 - Procurement
 - Costs Analysis
